

Don Hancock, 96, US Navy, 1945-1947, WWII, died March 21, 2024. Married to Unit 4 member Sally who survives him.



**Dwaine Jones**, 97. US Navy, joined 1942. He was present in Okinawa Bay on Sept. 2, 1945 when the treaty to end WWII was signed. He died April 1, 2023.



Philip Peoples, 98, US Air Force, serving as a fighter pilot in WWII flying the P-47 in Italy with the 346th squadron. He died May 14, 2023.

**Eugene Cotter,** US Coast Guard, Korea, died 2022

Laurel Davis, 89, US Army, Korean War era, was a dedicated enlistee at Beale Air

Force Base 1953-1955. He died December 5, 2023.

William Elkins, WWII, died 2014

**Thomas Marshall,** US Air Force, Korea, died 2022.
