#### **KOREAN WAR POW/MIA HONORED**

In 1950 US Army Corporal Norvin Brockett of Powell Butte was declared missing in action in North Korea. In 2021, nearly 70 years later, his remains were recovered and laid to rest at Arlington National Cemetery with full military honors.

On June 15 members of Brockett's family were present to remember and honor him with a ceremony at Ochoco Creek Park in Prineville, dedicating a new Fallen Hero Memorial Highway sign, now installed on US Hwy 26 just east of Prineville city limits.

Post 4 member and Chairman of Bend Heroes Foundation, Dick Tobiason, spearheaded the ceremony and authorization of the Memorial Highway sign by ODOT.

While the remains of only 44 MIA veterans from Oregon, including CPL Brockett have been recovered. identified, and returned to families over the last 41 years, another 973 Oregon Veterans still remain Missing in Action. The successful recent recovery of CPL Brockett's remains provides hope for more recoveries and returns to MIA families, Tobiason said.

#### A LITTLE HISTORY LESSON

Independence Day, known colloquially as the Fourth of July, is a federal holiday in the United States commemorating the Declaration of Independence, which was ratified by the Second Continental Congress on July 4, 1776, establishing the United States of America.

The Founding Father delegates of the Second Continental Congress declared that the Thirteen Colonies were no longer subject (and subordinate) to the monarch of Britain, King George III, and were now united, free, and independent states. [1] The Congress voted to approve independence by passing the Lee Resolution on July 2 and adopted the Declaration of Independence two days later, on July 4.
